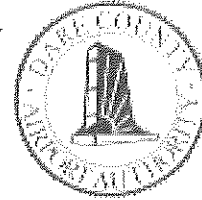

DARE COUNTY AIRPORT AUTHORITY MINUTES of the October 28, 2020 MEETING

Chairman Davidson called the October 28, 2020 meeting of the Dare County Airport Authority to order at approximately 4:02 pm.

ITEM 1 - Public Comments:

John Ratzenberger, Airport Museum Curator – Mr. Ratzenberger reminded the members that June 2021 would be the 50th Anniversary of the Airport Authority and Dwight Wheless artifacts. Mr. Ratzenberger will complete setting up the display with all the items in the museum for viewing. Chairman Davidson asked George Henderson if he would be willing to help with the planning committee for the celebration event.

No public was present and no public comments were submitted prior to the board meeting.

ITEM 2 - Engineer's Report:

John Massey updated on the following: (see attached)

- *Apron Pavement Rehabilitation* – Monday October 26th, John Massey and David Daniels had a conference call with Jamie Fuller, the NCDOA Airport Project Manager for northeastern North Carolina. Jamie indicated that award of construction funding for the apron pavement rehabilitation project would be on the agenda for the November 5th NCDOT Board of Transportation meeting. If approved, Talbert & Bright will work with David Daniels to establish dates for bid advertisement, pre-bid meeting and bid opening.
- *Runway 23 Land Acquisition* – the grant for acquisition of four parcels in the approach to Runway 23 has been finalized by NCDOA and a Notice to Proceed has been issued. The acquisition will allow the airport to control the land within the Runway 23 RPZ and allow the airport to remove obstructions from the approach. Fee simple acquisition is proposed for all properties. This grant will cover all preliminary land acquisition tasks including appraisals,

review appraisals, surveys, Phase 1 Environmental Due Diligence Audit, engineering, legal, and administrative work. A follow up grant will be needed for the actual land acquisition.

Talbert & Bright has coordinated General Information Notices and Right of Entry Forms with David Daniels and Robert Hobbs to send to the three property owners. The Signed Right of Entry Forms has been returned by City Beverage and Roughton. Another contact was made by one of the Airport Authority members to Basnight Enterprises LLC to see if they would be willing to sell or possibly consider a land swap. Further discussion with the property owner will occur to understand their willingness to possibly swap their parcel or sell the entire parcel. The Boundary Survey and Phase I Environmental Due Diligence Audit work will commence on the City Beverage and Roughton parcels. Appraisal work will follow completion of the survey and environmental work.

George Henderson stated the he did meet with Mark Basnight this week. Mr. Basnight indicated that he was not interested in selling the smaller parcel track but might be interceded in trading a track of land. Chairman Davidson asked George if he would try to meet with the property owner to see if there was any interested in other surrounding airport property.
