Liability Insurance –
 Chairman Davidson contacted Redden-Wood & Associates, Inc. the Airport's Insurance Representative regarding the Airport's current liability coverage and Towers Contract.

The Representative stated that he was familiar with all the Airport's policies and that it was okay to contract for Control Tower Services this summer. It should not have an effect on the current premium policy. The Representative will contact the Underwriter and follow-up with Chairman Davidson.

Attorney Hobbs suggested to contact other airports that might have similar tower services and see if they had any special liability coverage. It was also suggested to obtain a full copy of the airports current policy and have it reviewed in detail before next year.

 summer. The housing accommodations have not been signed a contract yet.
 Director Daniels has researched for housing options and the same rental house
 from last year is available. A final selection will decided this month.

It will make it a simpler process by reducing the time spent talking to Cherry Point approach and will give great data of aircraft activity. BE IT ORDAINED by the Dare County Airport Authority of Dare County, North Carolina that, pursuant to Section 13.2 of Chapter 159 of the General Statues of North Carolina, the following Capital Project Ordinance is adopted:

Section 1:	The project authorized is for the Runway 17 Approach Land Acquisition to be financed by the State Aid State Block Grant Program; a grant from the North Carolina Department of Transportation/ Airport Improvement Program Funds Fiscal Year 2016, 2017, 2018 Non-Primary Entitlement funds and by using the In-Kind funds allocated to the Airport as local match.

Section 5:	The Finance Officer is directed to report, on a monthly basis, the financial status of the project as a part of the normal monthly reporting process currently in place.
