New Business

USCG Report

• John Ahlen reported the Coast Guard moved buoys 12A, 15, 17 in Hatteras Inlet and Barney Slough to mark shoals. Plan is to put a couple more buoys in Sloop and move the buoy south near the entrance to the Connector Channel to avoid confusion. Steve said there have been no major incidents in the Connector Channel in the last month. Some shoaling is appearing near buoy 8.

Corps Report

- Jeremy Smith stated they are planning to survey the Connector Channel next week. The Murden will be working Bigfoot Slough before heading to Manns Harbor for maintenance. The Merritt is working the west side of Oregon inlet and after final concurrence from the resource agencies, the Snell will soon start dredging.
- The Corps is still tracking a October 7th realignment date. Resource agencies are still
 reviewing. Barton commented the realignment letter projected anytime of year dredging for
 Sloop and South Ferry Channel may be approved.
- Barton reported the cultural resource survey has been sent as of last Friday and provided to the agencies. Only items in the area were the cables.
- KP asked the Corps about getting the Merritt on the schedule to proactively dredge before there are major issues. Jeremy is looking at early October unless the shoaling worsens before. Jeremy and Barton will coordinate. Right now we are out of the environmental window and we do not have permits for portions of the channel where shoaling is located.

NCDOT Ferry Report

- Catherine reported the ferries were able to access Stumpy Point and Rodanthe. There is some shoaling in Rodanthe restricting the movement of the dredge.
- The majority of South Dock work is complete, but the spoil site is full. They will be back in March to complete dredging.

- Barton and Jeremy spoke about the Rollinson Realignment and that it should fall under the long-term MOA.
- The agencies are reviewing the South Ferry expansion permit application.
- With the State of Emergency expiring, the Waterways Commission will need to return to in person meetings. Odd months in Manteo and even months in Buxton.
