Discussion Regarding the Land Use Plan Update

Recommended revisions to the land use plan were discussed for the following management topics:

- Management Topic #2 Land Use Compatibility
- Management Topic #3 Infrastructure Carrying Capacity
- Management Topic #4 Natural Hazard Areas
- Management Topic #5 Water Quality
- Management Topic #6 Local Areas of Concern

This was a word-by-word review with a number of changes made regarding grammar, sentence structure, and content. Consistency within management topics was a priority. Following is a sample of some of the issues discussed under each management topic.

Land Use Compatibility: drive-thru businesses, land disturbance, fill, and having historical artifacts remain in Dare County.

Infrastructure Carrying Capacity: minimum lot sizes, wastewater, ferries, trams for passenger ferries, waterways, dredge spoil sites, energy sources, and mineral extractions.

Natural Hazard Areas: living shorelines, flood hazards, flood insurance rate maps, storm sand removal, and climate change.

Water Quality: stormwater, flood water pumping, wetlands, fisheries, and floating structures.

Local Areas of Concern: off-road vehicle access, federal and state support, stormwater management plan, tourism, cost of living, substance abuse, housing, waterways, and insurance.

In addition, there was a discussion regarding private sector employer responsibility as it relates to their employees' housing and/or transportation.

Planning Board Members and Attendance

This will be the last Planning Board meeting for Charles Read. He and his wife are moving out of Dare County. Chairman Finelli thanked Mr. Read for his service and Mr. Read expressed his appreciation of the Dare County staff and board members.
